### New Vote by Mail-In Ballots for 2018 Annual Meeting

The Flint Hills RECA election voting process will be changing for the 2018 election of the Board of Trustees. Members will be receiving a mail-in ballots to elect trustees. The new mail in ballot voting process allows members/owners the opportunity to cast their vote by mail. Following is an explanation of how the new election process will work.

#### **Nominating Trustee Candidates**

The board-appointed nominating committee will select candidates to run in the four districts that will be up for re-election in the year 2018. The names and addresses of the appointed nominating committee was listed in the Flint Hills RECA's December 2017 *Kansas Country Living*.

The nominating committee will meet on Jan. 4, 2018, to choose two (2) qualified candidates from their respective district to be voted upon by the members to fill the trustee positions whose terms of office are set to expire at the next (2018) annual meeting. Nominations for a qualified candidate may also be made by petition filed at the Council Grove office on or before the close of business on the fifteenth (15th) day following the nominating committee's selection of nominees, which will be January 19, 2018. The petition must be signed by not less than 5% of members of the district for whom the trustee is to be elected. All signatures must be obtained within sixty (60) days prior to the date nominations are filed at the headquarters' office. The candidates(s) nominated by petition must meet the same qualifications as any candidate nominated by the nominating committee.

#### Voting

The election of trustees shall be by mail in ballot. Only those nominees selected by the nominating committee or nominated by petition shall appear on the mail-in ballot. The ballots will be mailed to all active members the second week of February 2018. All ballots must be returned to the Flint Hills RECA office by March 9, 2018. The board-selected election committee, consisting of at least three qualified members of the Cooperative, will be responsible for opening and counting all mailed in ballots. The election committee will follow a confidential counting process during

the ballot opening meeting held on March 14, 2018.

#### **Annual Meeting**

The voting results will be announced, along with other Cooperative business, at the March 20, 2018 Annual Meeting and will also be posted in Flint Hills RECA's section of your April 2018 Kansas Country Living magazine.

Your attendance at annual meeting is important because Flint Hills RECA is run by a democratically elected Board of Trustees. They are a board who is given the privilege to serve because of your vote. The trustees you vote for are a part of your local communities and are committed to remain dedicated to providing its member/owners, safe, reliable, and affordable electric service.
